RESOLUTION NO. 4 OF 2021

**A RESOLUTION TO APPOINT MEMBER OF
THE WILLISTOWN TOWNSHIP ZONING HEARING BOARD**

WHEREAS, the Township of Willistown has enacted a Zoning Ordinance and established a Zoning Hearing Board in accordance with the requirements of the Pennsylvania Municipalities Planning Code (“MPC”); and

WHEREAS, Section 903 of the MPC provides that members of the Zoning Hearing Boards are to be appointed by resolution; and

WHEREAS, the Board of Supervisors desires to appoint a member of the Zoning Hearing Board to fill an unexpired term.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the Township of Willistown, Chester County, Pennsylvania as follows:

Section 1. Pursuant to Section 903(a) of the Pennsylvania Municipalities Planning Code, 53 PS 10903(a), the Board of Supervisors reappoints **Thomas W. Flynn III** as a member of the Zoning Hearing Board of Willistown Township, Chester County, Pennsylvania.

Section 2. In the event any provision, section, sentence, clause, or part of this Resolution shall be held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such invalidity, illegality, or unconstitutionally shall not affect or impair the remaining provisions, sections, sentences, clauses, or parts of this Resolution it being the intent of the Board of Supervisors that the remainder of the Resolution shall be and shall remain in full force and effect.


Section 3.



RESOLUTION NUMBER 5 OF 2021

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF
WILLISTOWN TOWNSHIP, CHESTER COUNTY, DESIGNATING
EMERGENCY SERVICE PROVIDERS FOR WILLISTOWN TOWNSHIP.**

WHEREAS, Willistown Township is responsible under the Second Class Township Code for the public safety of the residents of Willistown Township; and

WHEREAS, the Board of Commissioners of the County of Chester has requested that Willistown Township provide a resolution outlining the methods and agencies chosen to fulfill the public safety needs of the Township for the efficient administration of the integrated emergency communications system of the Chester County Department of Emergency Services.

NOW, THEREFORE, BE IT RESOLVED the Paoli Fire Company of 69 Darby Road, Paoli, PA 19301; the Malvern Fire Company of 424 East King Street, Malvern, PA 19355; the Goshen Fire Company of 1320 Park Avenue, West Chester, PA 19380; and the Newtown Square Fire Company #1 of Newtown Square, PA 19073 will be first due to provide fire protection in their respective designated areas on Exhibit A, attached hereto, combined with the use of Automatic Vehicle Location services for next due fire responses to the Township;

FURTHER, BE IT RESOLVED the Malvern Fire Company will provide Advanced Life Support (ALS) service to Willistown Township;

FURTHER, BE IT RESOLVED Paoli Fire Company, Malvern Fire Company and Goshen Fire Company will be first due to provide Basic Life Support (BLS) service for the respective designated fire areas of Paoli, Malvern, Goshen and Newtown Square; attached hereto, combined with the use of Automatic Vehicle Location services for next due ambulance responses to the Township;

FURTHER, BE IT RESOLVED the Willistown Township Police Department will provide full-time police protection;


FURTHER, BE IT RESOLVED Martin F. McKenzie is designated Emergency Management Coordinator;

FURTHER, BE IT RESOLVED that the Board of Supervisors of Willistown Township has reviewed and revised, if necessary, and adopted the Willistown Township Emergency Operations Plan, and has reviewed and adopted the National Incident Management System (NIMS) as a common operating practice; and






