RESOLUTION NO. 20 OF 2022

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF WILLISTOWN
TOWNSHIP, CHESTER COUNTY, AUTHORIZING THE DISTRIBUTION
OF FUNDS PROVIDED BY THE AMERICAN RESCUE PLAN ACT
LOCAL FISCAL RECOVERY FUNDING PROGRAM.**

WHEREAS, Willistown Township (the “Township”), a second class township located in Chester County, Pennsylvania, received funding from the Pennsylvania Department of Community and Economic Development through the COVID-19 American Rescue Plan Act (the “ARPA”) Local Fiscal Recovery Funding program (the “Program”); and

WHEREAS, the Township received Five Hundred Eighty Thousand Fifty Eight Dollars and Twenty Nine Cents (\$580,058.29) in Program funding in fiscal year 2022 (the “ARPA Funds”); and

WHEREAS, the ARPA allows ARPA Funds to be used for various purposes, including assistance to nonprofits and industries impacted by the public health emergency, to respond to workers performing essential work during the public health emergency, for the provision of government services to the extent of any reduction in revenue due to the public health emergency, and to make necessary investments in water, sewer, or broadband infrastructure; and

WHEREAS, the Board of Supervisors of Willistown Township (the “Board”) wishes to disburse the ARPA Funds in accordance with state and federal laws and regulations to provide appropriations to nonprofit libraries and emergency service providers who performed essential work for, and continued to provide government services to, the Township and its residents during the COVID-19 pandemic; and

WHEREAS, the Board also intends to appropriate ARPA Funds for the provision of stormwater mitigation and improvements to stormwater infrastructure.

NOW, THEREFORE, BE IT RESOLVED and **ADOPTED** by the Board of Supervisors of Willistown Township, Chester County, as follows:

Section 1. The Board of Supervisors hereby appropriates ARPA Funds in the amount of One Hundred Seventy-Four Thousand Seventeen Dollars and Forty-Eight Cents (\$174,017.48) to nonprofit library and emergency service providers, as follows:

Newtown Square Fire Company \$8,892.29
Goshen Fire Company \$23,474.96
Paoli Fire Company \$45,122.73
Malvern Fire Company \$62,106.84
Malvern Library \$17,210.33
Paoli Library \$17,210.33

Section 2. The Board of Supervisors hereby appropriates ARPA Funds in the amount of Four Hundred Six Thousand Forty Dollars and Eighty-One Cents (\$406,040.81) to stormwater mitigation and infrastructure projects within Willistown Township.


Section 3. This Resolution shall become effective immediately upon adoption.




