RESOLUTION 4 OF 2017

**A RESOLUTION SETTING THE ODINARY AND CUSTOMARY FEES CHARGED BY
THE TOWNSHIP'S ENGINEER(S), CONSULTANT(S), AND SOLICITOR**

WHEREAS, by virtue of the provisions of Act 170 of 1988 and the amendments to the Municipalities Planning Code ("MPC"), the Township may enact a Resolution or Ordinance setting forth the ordinary and customary fees charged by the Township's Engineer(s), Consultant(s), and Solicitor.

WHEREAS, the Township is permitted by virtue of Section 32 of Act 170 of 1988 (amending 503 of the MPC) and Section 389 of Act 170 of 1988 (amending 510 of the MPC) to prescribe that a subdivision and land development applicant pay the reasonable and necessary expenses incurred by the Township for plan review(s) and inspection of improvements if such a Resolution or Ordinance is in effect.

WHEREAS, the Township's General Engineer, Traffic Consultant, Engineer for Plan Examiner/Building Inspector, Planning Consultant, Historical Commission Consultant, Township Planner, and Solicitor have advised the Township of the fees to be charged the Township for the rendering of such services.

AND NOW, it is hereby **RESOLVED** THIS 3rd day of January, 2017, that the Board of Supervisors finds that the fees quoted by the Township's Wastewater Engineer – Carroll Engineering, the Township's Professional Planning Services– Gaadt Perspectives, the Township's Zoning Hearing Board Solicitor – Gawthrop Greenwood PC, the Township's Traffic Engineer – Heinrich & Klein Associates, Inc., the Township's Planning Engineer/Building Inspector – Keystone Municipal Services, the Township's Solicitor – Lamb McErlane PC and the Township's Engineer – Yerkes Associates are reasonable and commensurate with similar services provided in the community, and are hereby set forth as follows:




