Board Candidate Interview Discussion: Appointment Recommendation(s) to Supervisors for 3 candidates. The Board currently has only one opening. Mr. Vaskas, Mr. Lehr, and Ms. Hundt Mr. McHugh announced that he will step down after this meeting. Mr. Lehr asked if he would continue to serve as a liaison to the Board of Supervisors. Mr. McHugh agreed. Mr. Kacergis announced that he was going to step down after this meeting. Mr. Lehr asked if he would continue to be the liaison to and represent the Parks & Recreation Board on the Open Space Review Board. Mr. Kacergis agreed. Mr. Vaskas and Mr. Lehr recommended appointment of all three new candidates in lieu of these recent resignations. Ms. VanValkenburgh motioned that the Board recommend the appointment of the slate of three candidates to the Supervisors pending the formal resignations, Mr. Kacergis seconded, all in favor. Mr. Lehr and Mr. Vaskas expressed their thanks and the thanks of the Board to Mr. McHugh and Mr. Kacergis for their dedicated service. Mr. Lehr noted that Mr. McHugh was the longest-serving member of the current board, and Mr. Kacergis was third in tenure.
